PART III
NARRATIVE SUMMARY

A. GENERAL (S) Throughout the month of April, 1968, 3/26 (-) (Hein) engaged in Operation "Crisis Hills" in the Charlie Ridge / Happy Valley area. The mission of the BLT was initially to locate and block possible routes of egress available to the enemy and prevent his escape to the west as well as from the 7th Marines and 31st AVNAs closed in from the east and south upon the suspected NVA base camps in the area. Upon capture of an NVA S/Sgt by a recon unit who gave pie-point information regarding the 31st NVA Regimental Headquarters, the BLT's mission was changed to that of finding and destroying this headquarters complex and leaving these companies in the assault and leaving one company back for fire base security. As the three assault companies, Delta, Echo and Lima, began recovering weapons and document caches, the enemy's intention became clearly that of harassment and delaying actions. A second POW captured by the 7th Marines near the end of the month confirmed that the 31st NVA Regiment had been given orders to break up into squad sized units, disperse, avoid contact and to re-assemble in the base camp area as soon as the Marine units were seen leaving the area.

The BLT accounted for 360 NVA/VC KIA during this month. In addition, destroyed destroyed the extensive regimental and battalion hospitals and bunker complexes. Large caches were uncovered with cross-stored weapons, rocket launchers and numerous classified documents which have yet to be fully evaluated.

B. ADMINISTRATION (C) During the period 1-31 April, administrative elements of the BLT were located at Camp Blair, Hill 35; this included C Co 1st Bn 1st Regt, 4th Bn 1st Regt, Battalion 3-1, Battalion 3-2 and 3-3 regt, Battalion 3-4, BAC administration, Company offices, Accounting, Supply and IA.

15 May 1969C. INTELLIGENCE (S)

1. Enemy Situation Enemy forces in the BLF 3/26 "Oklahoma Hills" A.O. were estimated at 700 NVA of the 141st Regiment and 520 of the 360B Artillery Regiment.

2. Enemy Mission The enemy mission in the A.O. was to defend the headquarters of the 141st Regiment at all costs and evade contact in the outlying areas. After sufficient time for the enemy to move some of his equipment and documents his mission was changed to evade the allied forces and just harass with sniper and harassing fire.

3. Weather The maximum temperature for this period was 90 degrees. The low was 70 degrees and the mean temperature was 80 degrees. The relative humidity was 75% and the precipitation totaled 2 inches.

4. Terrain The terrain in the operation area was one of double canopy, forests and heavy brush, extremely steep mountains broken with deep draws and intermediate streams in each draw.

5. Avenues of Approach Unmarked trails running in all directions.

D. CIVIL AFFAIRS/CIVIC ACTION (C) There was no civic action conducted on this operation.

E. PSYCHOLOGICAL OPERATIONS (C) Chieu Hoi broadcasts were conducted for a period of four days during the operation at FSB Rattlesnake. Results of broadcast proved negative.

F. FIRE SUPPORT (S) During this period, supporting arms were used extensively in all aspects of the operation. Special emphasis was given to day and night IRU fires. "W" Btry 1/13 and "C" Btry 1/13 provided direct support for the battalion. 3rd Battalion, 11th Marines, 1st 155 Gun Platoon, 1st 8 inch Platoon and 27MM Gun Platoon provided general support.

G. AIR SUPPORT: (S)

1. Air support was requested by the BLT FAC/AJO through 7th Marines.

2. During the period 1-30 Apr 69:
- 25 medevacs were called
 - 2030 troops were heli-lifted for tactical deployment
 - 43 FPQ's were run on enemy positions
 - 25 air strikes were run on enemy positions
 - 7 over-flights of the A.O. were utilized.

H. LOGISTICS: (C)

1. Logistical support was satisfactory. Transportation during this period was provided by helicopters operating from the LSA located at Camp Marx to field units operating in the Worth and Charlie Ridge areas.

2. Maintenance support was provided by normal Marine Corps support facilities located at Delang. No unusual maintenance problems were encountered.

I. COMMUNICATION: (C)

1. General. During the period of 1 April through 30 April 1969 inclusive, the communication platoon furnished the necessary communications to support the battalion landing team in operation "Oklahoma Hills".

Although tree top antennas were employed to the extent possible, maximum communications in the mountainous jungle terrain was a continuous problem.

Frequency interference was experienced from time to time and appropriate reports submitted.

The number of stations operating on the air support net caused a problem. It was suggested some units switch to the secondary frequency. The 7th Marines communication-electronics officer said it was not feasible and refused the request.

2. Radio. All functional and tactical radio nets were guarded at the BLT C.P. The rear C.P. monitored the BLT TAC #1 net.

The four air radio team dispatched to RC BA MA on 28 March 1969 to establish a relay site for the BLT TAC and logistics support net maintained their site throughout the entire operation.

3. Message Center. The 7th Marine Regiment maintained the communication and crypto guard, with courier delivery and pickup provided by BLT 3/26 message center.

Courier service between the BLT C.P. and the rear C.P. was established and usually occurred every two or three days, depending on helicopter availability.

4. Wire/Radio Relay. No radio relay was employed. Normal internal wire lines were established in the rear C.P. with two trunk lines to the 7th Marine Regiment and one hot line from 7th Marine COG to BLT 3/26 rear COG.

Missory Bay 1/13 installed a switchboard at FSB Rattlesnake for internal communications. In addition, sound power telephones (TA-1's) were installed as hot lines between out posts.

J. MEDICAL-DENTAL (C)

1. Personnel. The Battalion Aid Station had a total of 3 medical officers and 55 enlisted. In addition the medical section had 4 shore party corpsmen and 2 collecting and clearing corpsmen under direct supervision of the BAS. Also attached were 10 other hospital corpsmen from the various attachments.

2. Capabilities. The medical department was able to treat most medical and some minor surgical problems. The capabilities were limited due to the lack of running water and availability of diagnostic procedures. Daily runs to NSA and 1st Med Bn were made for patient consultation and also to check the disposition of 3/26 patients.

3. Training. In garrison, corpsmen received on the job training directly from the medical officer. Corpsmen in the field carried out their own lectures on buddy aid and first aid also field sanitation. Indoctrination lectures were given to all new troops.

4. Dental. Hill 55 had a dental facility which was limited to emergency use only to 3/26. Most extensive dental work was done at DaNang or FLD. When the ship was available, patients were also worked on by the BLT Dental Officer.

5. Malaria Prophylaxis was accomplished by daily dosages of doxycycline and weekly doses of chloroquin/primaquin to both troops in the field and garrison.

6. Sanitation was supervised by the BLT medical department at Hill 55. Shower facilities were available as were 2 four balcon and 4 urinals. Cleaning of these facilities was done daily with soap and water and disinfectants. Weekly the Preventive Medicine Unit checked out the area for insect breeding areas, etc.

Lima company moving towards BLT objective "A" came upon a large NVA base camp. After a fire fight with approximately 20 NVA, enemy broke contact and fled. There were more than 30 well built hootches which could have held 30 persons each. Also found 01 operating room, 250 empty bottles of penicillin and streptomycin (made in San Francisco by American Chemical Drug Company), 03 SKS rifles and documents. Results 01 USMC KIA, 01 USMC WIAE and 01 NVA KIA. Weapons and equipment found sent to S-2.

1400H

Lima company continuing to search base camp found fresh grave yard containing 35 NVA bodies. Bodies all had bullet holes and shrapnel wounds. Results 35 NVA KIA.

1730H

Lima continuing to search found a large mess hall and kitchen with under ground stove pipes. Also 05 rully packed canvas packs with documents, clothing and white cloth apparently used as bandages. Gear sent to S-2.

12 April 69
1630H

Kilo 3/7 recon patrol found bunker and hootch complex. Checked hootches and bunkers and found false bottom containing 030mm grenades, maps, compass, binoculars, mortar plotting board and firing table. Sent equipment to S-2.

1900H

Kilo 3/7 patrol continuing to search found additional 030mm, compass, 17 7.62 model 1944 carbines, 01 7.62MM sub-machinegun model 1944, 10 03 Springfield rifles, 05 French 36's, 01 BAR, 01 DaNang City map, 01 map of Hill #55, 01 map of Marble Mountain area, 05 ChiCom maps of unknown areas and 01 US map of Quang Bac. Also a 10" stack of documents including rosters, lists, supply accountability table, letters, diary and part of a mortar table. Also 01 hair cutting set, 50 new blue uniforms, 02 U.S. made field phones, 02 base sockets for 60MM mortar, 03 6" by 18" cases of artillery fire direction equipment, 01 night lighting device, and 20 graves. Results 20 NVA KIA; equipment sent to S-2.

Kilo 3/7 continuing to search found 01 82MM round, 01 ChiCom galvanometer, 02 barrel wrenches for artillery piece or recoilless rifle, 04 122MM rockets, 01 BAR magazine, 01 SKS rifle, 01 document indicating 571st was there and had 05 arty pieces and a strength of 1397 men. All equipment and documents were sent to S-2.

3. EXECUTIONa. Company of Operations

(1) BLP 5/26 (-) (Main) with four rifle companies, one provisional platoon, one engineer platoon, "C" Day 1/13 and Whiskey Day 1/13 conducts a helicopterborne assault into LZ Robin (via CG 132655); establishes FSB Bronco and conducts reconnaissance in force operations in western Foggy Valley, to find, fix and destroy enemy forces, caches, installations and fortifications.

(2) BLP 5/26 (-) (Main) on D-Day occupies and begins preparation of FSB Bronco on Hill 749 (via CG 125651). Additional FSB's will be established on North and Charlie Ridges as necessary.

b. Co K (-) (Main)

(1) At L-Hour land in LZ Robin (see Annex C) and provide perimeter security for subsequent landing of BLP units.

(2) Conduct reconnaissance (via CG 132655) to determine best possible site for BLP CP, SML and 4.2 mortar FSB to be occupied subsequent to the landing of all BLP units.

(3) Be prepared on order to conduct combat platoon size patrols in grids: 1365, 1264, and 1265.

(4) Be prepared on order to move to FSB Bronco (via CG 125651) providing security for movement of BLP CP, SML and 4.2 mortar platoons during initial move.

(5) On order proceed from FSB Bronco (via CG 125651) to BLP Objective 3 and conduct search and destroy operations and maintain a company blocking position oriented toward the southeast.

c. Co H (-) (Main)

(1) Land in LZ Robin (see Annex C) subsequent to FSB Company and immediately proceed to FSB Bronco site (via CG 125651) and begin rapid preparation of the FSB in order to land "C" Day 1/13 at the earliest possible time.

(2) Be prepared to provide perimeter security for the FSB during preparation and subsequent to the completion.

(3) On or about H+2 be prepared to receive Whiskey Day 1/13 into the FSB LZ.

(4) On or about H+3 be prepared to receive the BLP CP, and SML platoons.

SECRET**d. Go L (-) (Main)**

- (1) On D-Day land in LZ Robin (see Annex C) and seize BIF objective 1.
- (2) Establish a company combat operating base (COOB) and be prepared to conduct combat patrols and ambushes as directed by this headquarters.

e. Go I (-) (Main)

- (1) On D-Day land in LZ Robin (see Annex C) and seize BIF objective 2.
- (2) Establish a company combat operating base (COOB) and be prepared to conduct combat patrols and ambushes as directed by this headquarters.

f. Whiskey Btry 1/13

- (1) On D-Day land in LZ Robin (see Annex C) and be prepared to provide immediate on call fires for all BIF 3/26 units.
- (2) On order, on or about D+2 be prepared to displace by helicopter to FSB Bronco and continue the assigned mission.

g. Charlie Btry 1/13

- (1) On D-Day provide 1 platoon (see Annex A) to land with Mike Company in LZ Robin and begin immediate preparation of FSB Bronco.

3. INTELLIGENCE ACQUISITION TASKS**a. Orders to subordinate units.**

- c. What methods and techniques will the enemy employ to gain access to friendly positions and/or installations? Give special attention to infiltration of individuals or units by deceptive or covert means to include tunneling.
- d. What are the enemy reactions to defense and counter-measures against reconnaissance, surveillance detection devices and techniques? Give special attention to their methods of avoiding detection and contact with BIF forces.
- e. What land and water routes does the enemy use for infiltration of equipment and personnel?
- f. What is the attitude of the people towards friendly and enemy forces in areas defined as pacified, contested, or VC controlled? What factors effect these attitudes?

1. MISSION.

At 1-hour on D-Day land by helicopter in the vicinity of ZG133655 and establish FSB BROICO. Conduct reconnaissance in force operations in western HAPPY VALLEY to find, fix and destroy enemy forces, installations and fortifications.

2. GENERAL SITUATION.

a. Characteristics of area of operation

1. Military Geography

(a) Topography. The area concerned is bounded by coordinates (ZC0773), (AT9373), (AT9360), (ZC2154), (ZC0754), and is characterized by steep rugged mountains. The CHARLIE RIDGE complex situated in the southern portion of the area of operations, the BA HA mountains located in the north, HUI MANG mountains to the northwest, THE THURSON Mountain located in the south central section and the high ground over Look-in THUONG DUC VALLEY constitute dominant terrain features. These features rise sharply from adjacent river valleys with rough dissections scarring the densely vegetated slopes. In sharp contrast to the otherwise mountainous terrain in HAPPY VALLEY, centrally located in the operational area, local relief generally ranges between 500 and 1000 meters, the maximum elevation within the AO is Hill 1227 (ZC075635). The minimum elevation within the AO approximately 350 meters in the valleys located near the center of the AO. The floor of HAPPY VALLEY is approximately 350 meters above sea level.

(b) Hydrography. The SONG YAM flows south from the western end of HAPPY VALLEY to the SONG CON, thus forming the western boundary.

(c) Climate and Weather.

1. General. The climate of the area is monsoonal in nature. It is characterized by two major seasons; the southwest monsoon, and the northeast monsoon.

3. **Humidity.** Early morning relative humidities are normally above 90 percent.

(a) General. There are many trails in the area of operation. Some of these trails are capable of supporting vehicular, tracked and wheeled movement.

4. Reinforcements

The 2nd NVA Division generally located south and southwest of the area of operations is considered the principle external reinforcing command.

5. Strength and Weaknesses

(a) The enemy's primary strength lies in his knowledge of the area. Secondly, he could defend and/or attack upon terrain of his own choosing.

6. Analysis of Enemy Capabilities

a. Relative order of probability of adoption by enemy (in decreasing order of probability).

1. Withdrawal. In light of the 7th Marines mission and scheme of maneuver (i.e. attacking towards the center of the A.C. from the periphery in three directions simultaneously), the enemy's capability to execute a partial or complete withdrawal must be considered as the probable course of action.

2. Defend. Probable. The enemy in his present location is capable of initially defending against the entrance of friendly forces into the area of operation.

3. Attack. Not considered likely. Conflicting reports on the number of casualties suffered by the 141st NVA Regiment makes the attack phase unlikely.

4. Reinforce. Possible but not very likely. The enemy units within the area can reinforce internally at will.

5. Conclusion: enemy will initially defend against the entrance of friendly forces into the area of operations to that extent necessary to delay and harass. He will then withdraw his forces to defend those cache areas and installations he deems valuable. Ultimately, he will withdraw or go underground avoiding detection of involvement in major engagements.
